The organisation wanted to be able to handle larger customers with more sophisticated needs, which meant investing in a solution that could support business growth, as well complex discounting and stock matrices.

The powerful reporting capabilities of IRIS Exchequer have delivered the greatest changes at Tayberry. The team have created in excess of 50 individual reports that are used very regularly by accounts/sales/buying and other personnel.

Each report allows easy access to information that previously would have been manually generated. This not only saves untold hours of data entry time, but has had a huge impact on the sense of teamwork as everyone at Tayberry works together better with accurate and accessible information.

Beverley continues, "The reporting functionality of IRIS Exchequer has been positively life changing! This allows the sales staff to check they are meeting set targets each day, see levels of credit requests raised and identify any issues. Previously they would have had to approach accounts for the information to be generated through SAGE, which was a time consuming process.

"Sentimail is so useful as it allows us to offer a better and more efficient service to our customers," comments Beverley. "All information is emailed to sales staff out in the field, so they can check which orders have left the building each evening and resolve any issues. We are planning on using Sentimail for more automated reports in the future as it is working so effectively for us."

In the past, manual processes dominated many of Tayberry's accounting functions. The removal of these manual processes has had significant cost and time-savings for Tayberry.
