Gain maximum control of expensive stock-holding

Stock is the most critical element in any wholesale or distribution operation and the way IRIS Exchequer handles stock sharpens your competitive edge

IRIS Exchequer supports bar coding and, where your stock is situated at different locations, is able to monitor and report on this effortlessly. The ability to track batch and serial numbers by 'use by' dates is particularly useful for perishable items such as food, pharmaceuticals and photographic supplies. Furthermore, optimum use is made of costly space as a delivered item can be spread across your warehouse, loaded into different bins and locations yet with all information on it consolidated in your central business and accounts system.



Interactive stock drill-down provides a view of all stock groups, sub-groups and stock items. In-depth stock analysis enables you to assess which are your fastest - and slowest - moving lines and who is purchasing which products. On-screen enquiries make it easy to see how sales value, quantity and margin vary by month or year, with drill-down to the original transactions and the ability to split by any currency where you trade internationally.

IRIS Exchequer fully integrates with the web-based arm of your business, automatically processing orders placed on your website, updating stock levels and emailing confirmation to the customer. Its ability to support foreign language descriptions of stock supports overseas trading via the Internet.

The IRIS Exchequer Sentimail module allows you to access live stock information, at all times from wherever you are, and be kept informed of events such as stock levels falling below a minimum level, large orders being placed or a drop in your sales margin. You can then take swift, remedial action.

In fact, Sentimail offers wide-ranging support to your business. It also enables you to chase orders automatically, by sending alerts from the system when an order is due and assists credit control by automatically emailing a copy of the invoice for overdue payments. Once again, this off-loads a vital but routine task from your administration team.

Accurate stock forecasting, too, provides crucial support in today's challenging just-in-time operating environment. The IRIS Exchequer Stock Forecasting module handles this highly complex and time-consuming function. It predicts sales and usage, enabling you to maintain your stock at optimum levels: cash is not tied up in unnecessarily high stock levels, while customers' expectations for delivery are fulfilled.

Future sales are forecast based on sales history averages or trends, customer schedules, annual company/product growth, with monthly/seasonal factoring and manual overrides. Administration is further reduced by automatically creating purchase orders to support these predicted sales.

Superseded products will also be substituted by their replacements. In addition, a list of complementary products will also appear on-screen, prompting your agents to enhance your customer service, sales margins and competitive edge by suggesting additional products.

Customer and supplier preferences can be set for requirements such as preferred depot for despatch or even the design and content of the documentation. The module will support supplier pricing agreements and supplier codes.

Sophisticated customer-specific structures allow you to offer differentiated service: price bands, discount percentages or amounts, and mark up or margins can all be allocated and date limited. Set up in advance, they will come into force automatically on the appropriate date.

Scheduled and rush order processing can both be accommodated, and there is the ability to place orders on hold for multiple reasons. Customers can be sent an automatic order acknowledgement and any items missing from an order will be tracked.
